



LET'S DO IT FOUNDATION GENERAL TERMS AND CONDITIONS OF DONATIONS

These general terms and conditions of donations (“Terms and Conditions”) apply to any donation made to Let’s Do It Foundation (referred to as "us", "we", or "our"), a foundation established under the laws of the Republic of Estonia, with Estonian registry code 90010442 and its registered office at Telliskivi 60a, Tallinn 10412, Estonia. Donations can be made on the webpages www.letsdoitworld.org and www.worldcleanupday.org.

Use of donations

1. Donations will be used to organize the activities of Let’s Do It Foundation. The aim of Let’s Do It Foundation is to raise awareness of the problem of global waste pollution, to empower individuals in 150 countries to take action for a cleaner and healthier world, to develop technological tools to map the world’s mismanaged waste, to visualise the waste pollution hotspots, and to take action for other purposes that correspond to the mission, vision and articles of association of Let's Do It Foundation.

Currency of donations

2. Donations are made in euros (EUR), unless agreed otherwise.

Process of donations

3. Donations can be made by credit card, debit card, bank transfer or PayPal. You can make a single donation or regular donations.
4. Before we can process a donation, you must provide us with (i) your name, address and email address; and (ii) details of the credit or debit card that you wish to use if you decide to make the donation by using a credit or debit card. We will use this information to process your donation. It is your responsibility to ensure that you have provided us with the correct information. Let’s Do It Foundation processes the personal data provided by you in accordance with the Privacy Policy and applicable data protection laws.
5. After submitting your data, you will be asked to choose the amount of donation, the method of payment and whether you wish to make a single donation or regular donations.

6. Once you confirm to us through our website that you wish to proceed with your donation, your transaction will be processed through our payment services provider, Maksekeskus or Braintree, depending on your location. By confirming that you wish to proceed with your donation, you authorise Maksekeskus or Braintree to request funds from your credit or debit card provider.
7. When you submit your payment details, they will be transferred to our payment services provider, Maksekeskus or Braintree, and your payment data will be collected and processed securely by them. You should make sure that you are aware of the payment services provider's terms and conditions, which are different from our own, to ensure that you are comfortable with how they will process your personal data before you make a donation.
8. In case you choose to make the donation by credit card, you will be asked to fill in all the necessary data, such as the cardholder's name, the card number, date of expiry and the 3-digit security code. In case you choose to make the donation by Paypal, you will be directed to log in to your personal Paypal account. In case you do not have a Paypal account, you must create one in order to make the donation.
9. You can also make a donation by bank transfer. In case you wish to do so, you can find the necessary account details on the donations page on our Website: <https://www.letsdoitworld.org/donate/>.
10. Based on your location, different payment methods may be available for making donations.
11. We will not share your personal details with any other third party other than those stated in our Privacy Policy.
12. Let's Do It Foundation will provide you with a donation certificate upon your request.

Regular donations

13. When you set up a regular donation you will be scheduling a series of donations to be made on the day of the month that you choose until further notice. These Terms and Conditions will apply to each of the donations in that series.
14. By confirming that you wish to proceed with a regular donation you authorise our payment services provider Maksekeskus or Braintree to request funds from your credit or debit card on the day of each month that you set.

Refunds and Cancellation Policy of donations

15. As donations are considered to be voluntary gifts to our organisation, they count as non-refundable.
16. You may reclaim the donation from us under the Estonian Law of Obligations Act in cases referred to in subsection 268 (1) of the Act.
17. Regular donations can be cancelled upon your request by contacting us through our website. Regular donations made via bank transfer can be terminated by contacting your bank.

Tax-deductible donations

19. Donations will only be tax deductible in specific countries. Donations are tax-deductible for Estonian residents, and for citizens of the United States of America for gifts starting from USD 500 made through CAF America.
20. If you want to make a tax-deductible donation and you are an Estonian resident, please enter your personal ID number in the description box when making the transfer.
21. If you want to make a tax-deductible donation and you are a U.S. citizen, please use CAF for donating. The Let's Do It Foundation is recognised as a charitable organisation in Estonia and is able to accept tax-deductible donations from American donors in partnership with CAF America, which is qualified as a 501(c)3 not-for-profit organisation. 23. We reserve the right to amend these Terms and Conditions at any time by notifying you accordingly. If no objections are raised by you, any such amendments shall become effective 14 calendar days after the notification has been made.
